The meeting was called to order at 3:26 p.m.

Mr. Pryor provided the motion to adopt the agenda, seconded by Dr. A. Williams, and the motion was unanimously approved.

Dr. Simmer provided a motion to approve the April 18, 2024 minutes, seconded by Dr. A. Williams, and the motion was unanimously approved.

Dr. Richard provided context about the early childhood integrated data system policy statements. Dr. A. Williams made a motion to approve the Data Governance Membership Policy, seconded by Ms. Neeley and the motion was unanimously approved.

Dr. Simmer made a motion to approve the Data Governance Meeting Policy, seconded by Dr. Simmer and the motion was unanimously approved.

Ms. Curtin made a motion to approve the Data Governance Formation of Project Teams Policy, seconded by Dr. A. Williams and the motion was unanimously approved.

Ms. Curtin made a motion to approve the Data Governance Program Participation Policy, seconded by Dr. Simmer and the motion was unanimously approved.

Mr. McBride made a motion to approve the Data Governance Data Ownership Policy, seconded by Mr. Pryor and the motion was unanimously approved.

Ms. Gillum provided an update on the Child Care and Development Fund (CCDF) State Plan. She shared the changes to the plan that are from the changes to the 2024 federal rule in the following areas: 1) lowering family costs for child care; 2) improving payments to child care providers; and 3) making family enrollment easier and faster.

Dr. Ferguson shared the success of First5SC application in school districts in Allendale and Williamsburg counties.

Ms. Gillum reported on the Interagency Collaboration Committee and their progress on the SC Birth Through Five Plan data sources. She stated that they are in the process of reviewing the status of the 2024 priorities for the plan.

Ms. Mjartan reported on the activities of the ECAC. She provided an update on Palmetto PreK analytics and First Five SC analytics. She provided an update on the work of First Five For All and recent national presentations.

Chairman Morley made a motion to adjourn the meeting, seconded by Dr. Ferguson, and approved unanimously.

#### **POLICY STATEMENT**

The South Carolina (SC) Early Childhood Advisory Council (ECAC), as the governing body of the South Carolina Early Childhood Integrated Data System (ECIDS), is committed to ensuring that SC ECIDS data that are made publicly available are used appropriately and responsibly by decision-makers and other stakeholders. ECIDS data may be used for authorized purposes, including but not limited to research, policy analysis, program evaluation, and quality improvement initiatives related to children residing in or served in South Carolina. Data use must comply with applicable laws, regulations, and data use agreements.

#### **PURPOSE**

The purpose of the policy is to explain the circumstances under which SC ECIDS data can or cannot be used and the appropriate ways that SC ECIDS data can be used aligned with the key questions approved by the ECAC for the SC ECIDS. This policy describes aggregate data that are made publicly available for SC ECIDS initiatives, like through static reports or dynamic dashboards. This policy does not describe using data for research that requires child-level data, like those described in the "Data Access and Acquisition Policy".

#### **SCOPE**

This policy applies to all data collected, processed, and stored for any SC ECIDS initiative, including but not limited to personally identifiable information (PII), sensitive educational records, research data, and administrative data.

#### **DEFINITIONS**

- **Personally Identifiable Information (PII)** is any data that could potentially identify an individual, including names, addresses, social security numbers, or other identifying information.
- Sensitive educational records include data or information that are collected and stored for educational purposes that individual(s) may not want to be shared with others or could contain information that may cause harm to the individual.
- Research data are pieces of information that are collected for the purposes of conducting
  research or answering a research question, which could include data that have been adjusted
  based on administrative data or primary data collected for the purposes of conducting research.
- Administrative data is information about individuals or program operations that are collected and maintained as a part of the functioning of a service or program.
- **Participating programs** are programs that regularly contribute data to any SC ECIDS initiative (see "Program Participation Policy").
- **External/authorized users** are individuals or entities granted access to ECIDS data for legitimate purposes, including researchers, policymakers, program administrators, and other stakeholders.
- **Key questions** are the six key questions for SC ECIDS adopted by the ECAC in August 2021 and outlined in the Data Governance Charter.
- **Indicators** are measures or metrics used to answer a key question. Several indicators could be used to answer one key question.

#### SC ECIDS DATA GOVERNANCE MANUAL

• **Demographics** are groups of the population that are stagnant, like a child's birth year, or are subject to change, like a child's county of residence.

#### **ROLES AND RESPONSIBILITIES**

- Participating programs have data stewards, who are responsible for managing and maintaining data quality for their program (see "Data Quality Policy"), serving on the initiative specific data governance work group (DGWG).
- As outlined in the "Data Ownership Policy", participating programs are the final decision-makers
  for how data they share in the SC ECIDS is used. Individuals within program teams who have
  final decision-making authority is a program-level decision.
- External/authorized users are responsible for abiding by SC ECIDS data use policies and any rules specific to their data request (see "Data Access and Acquisition Policy").
- The DGWG is responsible for recommending data use policies for the SC ECIDS that align with
  participating programs' individual data use policies and for communicating and working with
  external/authorized users on requesting and accessing SC ECIDS data, as detailed in the "Data
  Access and Acquisition Policy".

## **PROCESS**

- 1. DGWG decides on a key question to start with and identifies indicator(s) and demographics to answer that key question based on the available data from the participating programs.
- 2. If additional data elements need to be contributed to obtain an indicator, an addendum to the relevant data sharing agreement is executed (see "Program Participation Policy").
- 3. Regardless of the ECIDS initiative, participating programs have to sign off on the indicator via a Data Sharing Addendum, which includes two consents obtained at different times: (1) indicates their agreement to use their data to calculate the indicator initially; (2) authorizes their indicator to be shared publicly on the dashboard.

## Research, Strategy, and Data Governance

Molly Tuck joined the ECAC in July 2024 as the Strategic Data Fellow through the Strategic Data Project (SDP) and will be serving as the Data Governance Coordinator for SC ECIDS work.

- Based at the Center for Education Policy Research at Harvard University, the SDP Fellowship
  is an intensive capacity-building program that places new data strategists and trains existing
  talented data strategists in education agencies to have an immediate impact on policy
  decisions that affect student outcomes.
- The Strategic Data Fellow position is funded by a two-year award from the Bill and Melinda Gates Foundation

# **Family-Centered Practice**

Two-generation Approach

- A video that showcases SC ECAC's two-generation approach to family services will be released in conjunction with the SC Summit on Early Childhood.
- ECAC staff members are participating in the SC Education & Workforce Portal Project Steering Committee. Economic and education pathways are essential to whole family prosperity and to positive early childhood outcomes.
